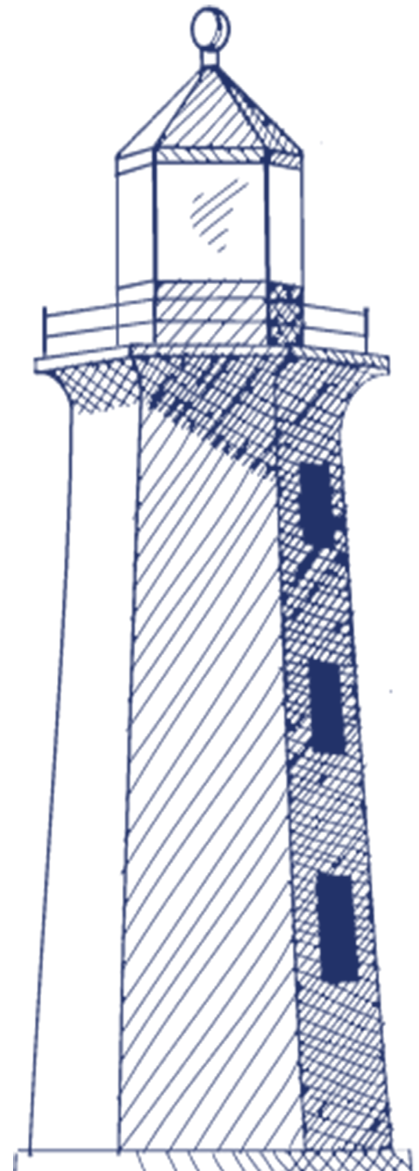

CONTRIBUTIONS TO PROTECTING OUR VOTE PAC DO NOT COUNT AGAINST THE BIENNIAL LIMIT THAT APPLIES TO AN INDIVIDUAL'S AGGREGATE CONTRIBUTIONS TO FEDERAL CANDIDATES, PACS, AND POLITICAL PARTIES.

FEDERAL LAW REQUIRES US TO USE OUR BEST EFFORTS TO COLLECT AND REPORT THE NAME, MAILING ADDRESS, OCCUPATION AND NAME OF EMPLOYER OF INDIVIDUALS WHOSE CONTRIBUTIONS EXCEED \$200 IN A CALENDAR YEAR.
